INTERNATIONAL."

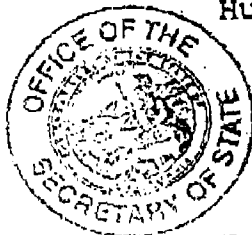
3. The foregoing amendment of the Articles of Incorporation
