INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, dated as of November 16, 2001 ("Assignment") by Deere & Company, a Delaware corporation ("Deere"), and John Deere Consumer Products, Inc., f/k/a Homelite, Inc., a Delaware corporation, ("JDCP") (JDCP together with Deere, "Assignors"), in favor of Techtronic Industries Co., Ltd., a Hong Kong company ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors do hereby assign, transfer, set over, and deliver to Assignee and its successors and assigns, all of the right, title, and interest of Assignors in and to the following, including all causes of actions, claims and demands or other rights for, or arising from, any infringement, including past infringement, all rights of priority under the International Conventions and any other international agreements to which the United States adheres, all income, royalties, damages, claims, and payments now or hereafter due or payable with respect thereto, and all rights corresponding thereto throughout the world:


