ASSIGNMENT AGREEMENT

This Assignment Agreement (this "Agreement") is entered into as of June 30, 2002, by and between ACE Products Enterprises, Inc., a New Jersey Corporation ("Seller") and Cymco, Inc., a Delaware corporation ("Buyer"). Capitalized terms used without definitions in the text of this Agreement shall have the same meanings ascribed to such terms in that certain Asset Purchase Agreement of even date by and between Seller and Buyer (the "Purchase Agreement").

Assignment. In accordance with and subject to the terms and conditions set forth in the Purchase Agreement, for valuable consideration received, Seller hereby irrevocably sells, conveys, assigns, transfers and delivers to Buyer Seller's entire right, title and interest in and to the Assets including all of the goodwill associated with the Assets. The Assets shall consist only of the, including, but not limited to, the trademarks CAMBER, AVANTI, CAMBER AVANTI, SAVAGE, and variation thereon, and all registrations related thereto, and the inventories of Seller related to the foregoing trademarks.

For the convenience of the parties, this Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.

This Agreement shall be governed by and construed in accordance with all applicable laws of the Commonwealth of Massachusetts.
