Trademark Security Interest

THIS TRADEMARK SECURITY INTEREST ("Security Interest") is made as of October 21, 2002 by HOMELITE TECHNOLOGIES, LTD., a company incorporated under the laws of Bermuda with an office at Cedar House, 41 Cedar Avenue, Hamilton HM12, Bermuda (the "Pledgor") to and in favor of WACHOVIA BANK, NATIONAL ASSOCIATION, a national banking association organized under the laws of the United States (the "Facility Agent"), in its capacity as collateral agent for the lenders pursuant to that certain loan agreement dated as of October 21, 2002 by and among Homelite Consumer Products Holding, Inc., as borrower, Homelite Consumer Products, Inc. and Techtronic Industries Company Limited, as guarantors, Commerz (East Asia) Limited as coordinating arranger, The Hongkong and Shanghai Banking Corporation Limited and Wachovia Securities, Inc. as arrangers, the lenders named therein (the "Lenders"), and the Facility Agent, as the same may be amended, supplemented or otherwise modified from time to time. (the "Loan Agreement"). This Security Interest is made in accordance with the Loan Agreement and the Security Agreement between Homelite Consumer Products Holding, Inc., Homelite Technologies, Ltd. and Homelite Consumer Products, Inc., as pledgors, and the Facility Agent, as pledgee, dated as of October 21, 2002 as the same may be amended, supplemented or otherwise modified from time to time (the "Security Agreement").

WHEREAS, the Pledgor has adopted, used and is using certain trademarks which are registered in the United States, all as set forth in Schedule A, which is attached hereto and made a part of this Security Interest (the "Marks");

WHEREAS, the Pledgor has warranted that it is the rightful owner of the Marks and that all assignments of the Marks to the Pledgor have been submitted for recordation with the United States Patent and Trademark Office ("U.S.P.T.O.");

WHEREAS the Pledgor is obligated to the Facility Agent pursuant to the Security Agreement;

WHEREAS pursuant to the Security Agreement, the Pledgor is granting to the Facility Agent, for the its benefit and the benefit of the Lenders, a security interest in the Marks and in all of the goodwill of the business(es) symbolized by the Marks and a conditional assignment of the Marks and of all of the goodwill of the business(es) symbolized by the Marks;

NOW THEREFORE for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Pledgor grants to the Facility Agent a security interest in each of the Marks, together with all of the goodwill of the business(es) symbolized by the Marks, and grants a conditional assignment of the Marks together with all of the goodwill of the business(es) symbolized by the Marks upon the occurrence and continuance of any Event of Default (as defined in the Loan Agreement), and upon notice from the Facility Agent to the Borrower (to the extent that such notice is required pursuant to Clause 13. 2 of the Loan Agreement). 
Security Interest is intended to and shall secure all of the Secured Obligations, as that term is defined in the Security Agreement.

FURTHER the Pledgor agrees, understands and acknowledges that the rights and remedies of the Facility Agent with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Security Interest are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.


