UNITED STATES TRADEMARK ASSIGNMENT

WHEREAS, POPE & TALBOT, INC., a Delaware corporation, and its subsidiary POPE & TALBOT WIS, INC., a Delaware corporation (hereinafter collectively and individually "P&T"), are the owners of the entire right, title and interest in and to the trademarks and registrations, pending "use" applications and pending "intent-to-use" applications for registration thereof in the United States Patent and Trademark Office; said registrations and pending applications are set forth more fully in Exhibits A, B and C attached hereto and incorporated by reference herein.

WHEREAS, PARAGON TRADE BRANDS, a Delaware corporation (hereinafter "Paragon"), is desirous of acquiring the entire right, title and interest in and to said trademarks and the registrations and pending applications for registration thereof, together with the goodwill of the business symbolized by said trademarks;

WHEREAS, P&T has intended to use the marks listed in Exhibit C in interstate commerce and has filed applications with the United States Patent and Trademark Office based upon its bona fide intent-to-use such marks in commerce, which applications were given the serial numbers shown, but has not yet filed allegations of use of the marks under Section 1(c) or 1(d) of the Trademark Act;

WHEREAS, Paragon is acquiring the entire business, or a portion thereof, to which the marks in Exhibit C pertain, as required by 15 U.S.C. § 1060; and

WHEREAS, Paragon and P&T executed an Asset Purchase Agreement dated December 11, 1995, which provides for the purchase by Paragon of said trademarks and the registrations and pending applications thereof, together with the goodwill of the business symbolized by said trademarks, from P&T;

TRADEMARK REEL: 2614 FRAME: 0688 NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, P&T does hereby assign unto Paragon P&T's entire right, title and interest in and to said trademarks and the registrations, pending "use" application and pending "intent-to-use" applications thereof identified as part of the entire business or portion thereof to which the marks pertain as required by 15 U.S.C. § 1060, together with the goodwill of the business symbolized by said trademarks, the same to be held and enjoyed by the same Paragon for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives as fully and entirely as the same would have been held and enjoyed by P&T if this assignment had not been made, together with all claims for damages and reason of past infringement of said trademarks and their respective registrations, with the right to sue for and collect the same for its own use and behalf and for the use and behalf of its successors, assigns and other legal representatives; provided, however, that P&T shall also retain the right to bring claims relating to past infringements.

AND, P&T hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements in conflict herewith.

AND, P&T hereby agrees to execute and sign all documents required to effect a recordation of the assignment of the above trademarks and registrations thereof before the proper office or agency.

AND, P&T agrees that the Commissioner of Patents and Trademarks is hereby authorized to deliver to Paragon, its attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Assignment.
