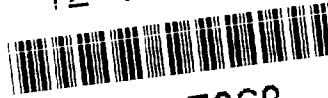

**ASSIGNMENT OF SECURITY INTEREST IN
TRADEMARKS AND SERVICE MARKS**

WHEREAS, Fleet National Bank, a national banking association having a place of business at 10 Fountain Plaza, Buffalo, NY 14202 (the "Assignor"), as agent for itself and other lending institutions which are parties to a Credit Agreement, dated as of March 31, 1998 (as amended and in effect from time to time), among Columbus McKinnon Corporation (the "Company"), the Assignor and certain other parties named therein, is the holder of a security interest in the trademarks, trade names, trade dress, service marks and other indicia of trade origin (and the goodwill associated therewith) identified on Exhibit A hereto (collectively, the "Marks") and in the registrations of and pending registration applications for such Marks in the United States Patent and Trademark Office ("PTO") identified on said Exhibit A pursuant to an Intellectual Property Security Agreement, dated as of March 31, 1998, between the Company and the Subsidiary Grantors named therein (collectively, the "Grantors") and the Assignor, and recorded with the PTO on May 4, 1998 at the Reel and Frame set forth on said Exhibit A; and

WHEREAS, Fleet Capital Corporation, a Rhode Island corporation having an office at One Federal Street, Boston, Massachusetts 02110 (the "Assignee"), as agent for itself and other lending institutions which are, or may in the future become, parties to an Amended and Restated Credit and Security Agreement, dated as of November 21, 2002 (as amended and in effect from time to time), among the Company, the Assignee and certain other parties named therein, is desirous of acquiring the security interest in the Marks (and associated goodwill) and the registrations thereof and registration applications therefor;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, as of November 21, 2002, the Assignor does hereby assign, sell and transfer to the Assignee, all of the Assignor's security interest in and to the Marks, together with (a) the registrations of and registration applications for the Marks, (b) the goodwill of the business connected with the use of, and symbolized by, the Marks and the registrations thereof, and (c) the right to sue and recover for, and the right to incomes, royalties, damages and other payments now and hereafter due or accrued and arising out of or in connection with, any and all past, present or future infringements, misappropriations or dilution of or damage or injury to the Marks or the registrations thereof or such associated goodwill and (iii) all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Grantors accruing thereunder or pertaining thereto.
