**RELEASE OF SECURITY INTEREST (TRADEMARKS)**

WHEREAS, J.B. Williams Company, Inc. (formerly known as "Brynwood Apparel, Inc."), a Delaware corporation (the "Borrower"), entered into a Security Agreement, dated as of August 1, 2001 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of The Bank of New York, as administrative agent (the "Administrative Agent") for the Secured Parties, as defined in the Security Agreement, and granted to the Administrative Agent a security interest in (among other things) the marks listed on Schedule 1 to the Grant of Security Interest (Trademarks), dated as of August 1, 2001, executed by the Borrower and filed in the United States Patent and Trademark Office on November 21, 2001 at Reel 002388 and Frame 0817 (the "Secured Trademarks").

WHEREAS, the Administrative Agent executed a Release of Security Interest (Trademarks), dated as of February 4, 2002, which released certain of the Secured Trademarks (the "Released Trademarks") in connection with the sale of the Released Trademarks by the Borrower to FASMA, LLC.

WHEREAS, pursuant to Article 10 of the Security Agreement, the Administrative Agent now desires to terminate and release its security interest in the Secured Trademarks as listed on Schedule A attached hereto (the "Remaining Trademarks").

NOW, THEREFORE, the Administrative Agent (without recourse or representation or warranty, express or implied) hereby releases the lien on, and assigns to the Borrower all right, title and interest of the Administrative Agent in, the Remaining Trademarks, together with the goodwill of the business symbolized by, or connected with the use of, the Remaining Trademarks and the applications and registrations thereof, and as part of the entire business or portion thereof to which any such Remaining Trademark pertains as may be required by 15 U.S.C. §1060, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof.

The Administrative Agent authorizes and requests the United States Patent and Trademark Office to note and record the existence of the assignment hereby given.


