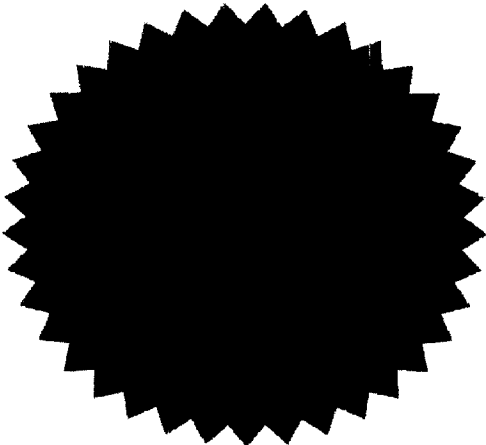

SECOND: That TMW Marketing owns all of the outstanding shares of the capital stock of Licensing I, consisting of 100 common shares.

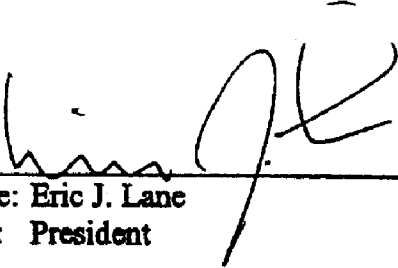

RESOLVED, that the proper officers of TMW Marketing are hereby authorized and empowered to file the necessary documents with the Secretary of State of the State of California, to incur the necessary expenses therefor and to take, or cause to be taken, all such further action and to execute and deliver or cause to be executed and delivered, in the name of and on behalf of TMW Marketing, all such further instruments and documents as any such officer may deem to be necessary or advisable in order to effect the purpose and intent of the foregoing resolutions and to be in the best interests of TMW Marketing (as conclusively evidenced by the taking of such action or the execution and delivery of such instruments and documents, as the case may be, by or under the direction of any such officer)."


