TRADEMARK SECURITY AGREEMENT TERMINATION

WHEREAS, Renaissance Government Solutions, Inc., a Delaware corporation, located at 189 Wells Avenue, Newton, Massachusetts 02159 (the "Debtor"), and NationsBank, N.A., a National Banking Association, located at 901 Main Street, Dallas, Texas 75202 ("Lender"), entered into a certain Trademark Security Agreement (the "Agreement"), dated as of February 24, 1999, which was recorded in the United States Patent and Trademark Office on May 10, 1999 at Reel 1898 and Frame 0340, that by its terms granted Lender a security interest in certain intellectual property listed on Schedule 1 (the "Trademarks") and all trademark applications and trademark registrations acquired or arising after the date of the Agreement;

WHEREAS, Renaissance Government Solutions, Inc., a Delaware corporation, located at 189 Wells Avenue, Newton, Massachusetts 02159 (the "Debtor"), and Bank of America, N.A. (formerly NationsBank, N.A.) a National Banking Association, located at 1455 Market Street, 5th Floor, San Francisco, California 94103-1399 ("Secured Party"), entered into a certain Amended and Restated Trademark Security Agreement (the "Agreement"), dated as of July 15, 1999, which was recorded in the United States Patent and Trademark Office on September 13, 1999 at Reel 1957 and Frame 0301, that by its terms granted Lender a security interest in certain intellectual property listed on Schedule 1 (the "Trademarks") and all trademark applications and trademark registrations acquired or arising after the date of the Agreement;

WHEREAS, the Agreements provide that Lender and Secured Party shall execute and deliver to the Debtor a termination of all security interests granted by Debtor upon the payment and full performance in full of all obligations incurred under the loan agreements; and

WHEREAS, the Debtor has or has caused to be paid and satisfied in full the obligations for which the security interest in the Trademarks was granted.

NOW THEREFORE the parties hereto agree that Lender and Secured Party hereby reassign to the Debtor the interest in the Trademarks in which Lender and Secured Party were granted a security interest under the Agreements. The Lender and Secured Party also hereby release its security interest in the Trademarks.
