AFFIDAVIT OF
LISA GREEN

I, Lisa Green, do hereby depose and say:

1. I am over the age of 18 and freely make this Affidavit.
2. I have personal knowledge of the use and status of the above named

registered trademarks (Marks) as they may relate to Hanover Direct, Inc.

3. From August 1996 to June 1997, I was the in-house legal counsel for Hanover Direct, Inc. (Hanover) familiar with its advertising and marketing; from June 1997 to January 1999, I was the outside legal counsel for Hanover advising Hanover on advertising and marketing; and from January 1999 to the present, I am the in-house legal counsel for Hanover in all areas. In these positions, I had the greatest familiarity than anyone connected with Hanover in the use, transfer, licensing, etc. of Hanover's trademark portfolio.

4. The Austad Company changed its name on December 13, 1999 to Hanover South Dakota Company. On December 25, 1999 the Hanover South Dakota Company was dissolved, its assets were distributed to Hanover Golf, Inc., and Hanover Golf, Inc. was dissolved as a corporation.

5. Austad Holdings, Inc. was until December 6, 1999, a wholly owned subsidiary of Hanover. On December 6, 1999 the name of Austad Holdings, Inc. was changed to Hanover Golf, Inc. and on December 25, 1999, Hanover Golf, Inc. was dissolved as a corporation.

6. Pursuant to an Asset Purchase Agreement entered into as of August 19, 1999 among Euclid Logistics, Inc., an Illinois corporation ("Buyer"), Hanover, Austad Holdings, Inc., a then wholly-owned subsidiary of Hanover ("AHI"), and The Austad Company, a then indirect wholly-owned subsidiary of Hanover ("TAC") (AHI and TAC, together, the "Sellers"), the Austad Company and Austad Holdings, Inc. sold and assigned the Marks set forth in Exhibit A, attached hereto and incorporated herein, to Euclid Logistics, Inc., as Buyer. It is my


understanding that Euclid Logistics, Inc. is owned by Mammoth Sports Group, Inc.

7. That for some reason, the assignment documents for these Marks were not filed with the United States Patent and Trademark Office.

8. That I do know that all of the files for the transfer of the trademark portfolio from Austad Holdings, Inc. and The Austad Company to Mammoth Sports Group, Inc. were transferred from our outside trademark counsel (Martin B. Schwimmer of Fross Zelnick Lehrman & Zissu, P.C.) to John L. Walsh of Aquilino, Welsh & Flaxman, PC of Arlington, VA. I have a copy of the transmittal letter dated January 11, 2000 from Mr. Schwimmer to Mr. Welsh. (See Exhibit B, a true and correct copy of the Schwimmer letter, attached hereto and incorporated herein. See also Exhibit C, a true and correct copy of the letter from Mr. Welsh to Mr. Schwimmer requesting such transfer, attached hereto and incorporated herein.)


