

TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of December 20, 2002, by ANTARES CAPITAL CORPORATION, a Delaware corporation, as Agent (“Agent”).

WITNESSETH:

WHEREAS, Agent and Voit Sports, Inc., a New York corporation (“Voit”), are parties to that certain Trademark Security Agreement dated as of August 5, 1999 (the “**Security Agreement**”; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement), pursuant to which Voit granted a security interest to Agent in, and a collateral assignment to Agent of, among other things, the Released Trademarks (as such term is defined below) as security for certain obligations owing by Bushnell Performance Optics, a Delaware corporation (“**Parent**”) to the financial institutions (collectively, the “**Lenders**”) from time to time party to that certain Second Amended and Restated Credit Agreement dated as of August 17, 2000, as amended, restated, supplemented or otherwise modified from time to time, by and among Parent, Agent and such Lenders; and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 12, 1999, at Reel 1936, Frame 0532; and

WHEREAS, Voit has requested that Agent release its security interest in the Released Trademarks and reassign the same to Voit.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged:

1. Agent hereby releases its security interest in all of Voit’s right, title and interest in and to all of the following:

(a) each Trademark, Trademark registration, Trademark application and Trademark license (together with any reissues, continuations or extensions thereof) referred to on Exhibit A attached hereto (collectively, the “Released Trademarks”), and all of the goodwill of the business connected with the use of, and symbolized by, the Released Trademarks; and

(b) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Released Trademark or (ii) injury to the goodwill associated with any Released Trademark.


