ASSIGNMENT

WHEREAS, Assignor owns all right, title and interest in and to the trademark METAMORPHOSIS for "perfume; make-up; hair lotions; face and body soaps; and non-medicated skin care preparations, namely, creams, lotions, moisturizers, serums, cleansers, facial masks, toners, gels, and sunscreens," U.S. Registration No. 2,189,486, and the goodwill attached thereto, and to the trademark METAMORPHIA for "cosmetics, namely, skin creams, body creams, cold cream, eye cream, skin lotions, skin moisturizers, skin cleansers, skin gels, skin toners and skin soaps, make-up, hair lotions, hair gels, perfumes and sun screens," U.S. Registration No. 2,236,736, and the goodwill attached thereto (together, the "Marks").

WHEREAS, Assignee wishes to acquire from Assignor, and Assignor wishes to assign to Assignee, Assignor's right, title and interest in and to the Marks, along with the goodwill represented thereby.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, agree as follows:

Assignor hereby sells, assigns, transfers and conveys to Assignee, all of
 Assignor's right, title and interest in and to the Marks, including United States Trademark

TRADEMARK REEL: 002648 FRAME: 0255 Registration Nos. 2,189,486 and 2,236,736 therefor, the goodwill of the business associated with the Marks and the right to recover for past, present and future infringements of the Mark.

- 2. Assignor agrees that, upon request it will, at any time without charge to Assignee but at Assignee's expense, furnish all necessary documentation relating to or supporting chain of title, sign all papers, take all rightful oaths, and do all acts which may be reasonably necessary for vesting title to the Marks and registrations therefor in Assignee, its successors, assigns and legal representatives or nominees.
 - Assignor represents, warrants and covenants that:
- (a) to the best of Assignor's knowledge, there is no infringement
 by others of the Marks;
- (b) no claim has been made that the use of either of the Marks does or may violate the rights of any third person, and to the best of Assignor's knowledge, there is no infringement by Assignor of the trademark rights of others;
- (c) Assignor is the sole and exclusive owner of the entire and unencumbered right, title and interest in and to each of the Marks free and clear of any liens, charges, encumbrances and adverse claims, including pledges, assignments, licenses, registered user agreements and covenants by Assignor not to sue third persons, other than the assignment created by this Assignment;
- (d) There are no outstanding or active license agreements with any third parties relating to the Marks and no assignment agreements relating to the Marks; and
- (e) Assignor has the unqualified right to enter into this Assignment and to perform its terms.

- 4. This Assignment will be binding upon Assignor, and its successors and assigns and shall inure to the benefit of Assignee, its nominees, successors and assigns.
- 5. This Assignment together with any additional documents necessary to effect the transfer of the Marks and registrations therefor constitutes the entire and exclusive terms and conditions with respect to the disposition of the Marks and supersedes any discussions, conflicting correspondence or other documents relating thereto and may only be modified in writing signed by both parties.
