TRADE MARK ASSIGNMENT

THIS ASSIGNMENT is made the 13th day of June the year Two Thousand and Two BETWEEN Bonar Floors Inc. of 7951 Industrial Highway, P.O. Box 10196, Macon, Georgia 31297, United States of America (hereinafter called "the Assignor") of the one part, and Bonar Floors Limited of High Holborn Road, Ripley, Derbyshire, DE5 3NT, England (hereinafter called "the Assignee") of the second part.

Recitals:

- (A) The Assignor is the registered proprietor of the U.S. Registered Trade Marks particulars of which are set out in Schedule I below hereto (collectively called 'the Trade Marks').
- (B) The Assignor has agreed to assign to the Assignee the Trade Marks together with the goodwill of the business of the Assignor concerned in the goods in respect of which the Trade Marks are registered upon the terms and conditions hereinafter appearing.

Operative provisions:

1 Assignment

In pursuance of the said agreement and in consideration of the sum of £10 (ten pounds sterling) now paid by the Assignee to the Assignor (the receipt whereof the Assignor hereby acknowledges) the Assignor HEREBY ASSIGNS unto the Assignee the Trade Marks and the full and exclusive benefit of each of them together with the goodwill of the business of the Assignor concerned in the goods in respect of which the Trade Marks are registered TO HOLD the same unto the Assignee absolutely.

2 **Assignor's obligations and warranties**

2.1 The Assignor shall at the discretion and expense of the Assignee execute any further document and do any such thing as the Assignee may require to enable the Assignee to become registered as proprietor of the Trade Marks and to secure the benefits of the rights hereby assigned.

2.2 The Assignor hereby warrants that:

2.2.1 it is the proprietor of the Trade Marks and has the full power to enter into this Assignment;

2.2.2 it has not granted any licences to use the Trade Marks;

2.2.3 it has not, either by act or omission caused and permitted anything to be done which might endanger the validity of the Trade Marks or the ability of the Assignee to register this Assignment;

2.2.4 it has not knowingly withheld from the Assignee knowledge of any circumstances that may endanger the validity of the Trade Marks or the ability of the Assignee to register this Assignment;

2.2.5 all renewal fees due in respect of any registered Trade Marks have been paid;

2.2.6 all previous assignments of the Trade Marks are valid and the Assignor is properly entered on the Register of Trade Marks as proprietor of the Trade Marks.

2.3 The Assignor hereby agrees to indemnify, and to keep the Assignee indemnified, against all actions claims proceedings costs and damages (including any damages or compensation paid by the Assignee on the advice of its legal advisers to compromise or settle any claim) and all legal costs and other expenses arising out of any breach of the warranties in clause 2.2 or out of any claims by a third party based on any facts which if substantiated would constitute such a breach.

3 Certificate of value

THE parties HEREBY CERTIFY that the transaction hereby effected does not form part of a larger transaction or a series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration exceeds £60,000.
