

ASSIGNMENT OF UNITED STATES TRADEMARKS

WHEREAS, TRISTAR CORPORATION, DEBTOR-IN-POSSESSION in the Chapter 11 proceeding, Case no. 01-53706, U.S. Bankruptcy Court, Western District of Texas, San Antonio Division, with its principal office at One Eurostar Drive, Pleasanton, TX 78064 (hereinafter "Assignor"), has adopted, used and is using the trademarks which are the subject of trademark registrations and applications with the United States Patent and Trademark Office, as set forth on the annexed Schedule (hereinafter collectively the "Trademarks");

and further, Assignor hereby covenants, agrees and undertakes to execute whenever requested by Assignee, any and all applications, assignments, lawful oaths and any other papers which Assignee may deem necessary or desirable for securing to Assignee or for maintaining for Assignee the Trademarks hereby assigned, without further out-of-pocket cost or expense to Assignor.

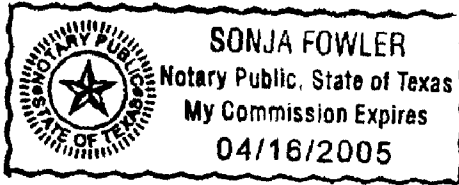
