IN WITNESS WHEREOF, the undersigned has caused this Termination of Security Interest and Assignment to be executed by a duly authorized representative as of the date first written above.

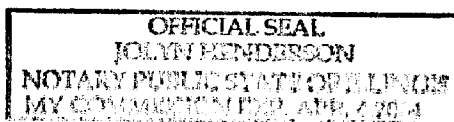
