**TERMINATION OF
TRADEMARK SECURITY INTEREST**

This Agreement is between Forbes Management Co. Inc. ("Forbes"), a New York corporation with its principal place of business at 60 Fifth Avenue, New York, New York 10011 (the "Grantor"), and Canadian Imperial Bank of Commerce ("CIBC"), a corporation with a place of business at 425 Lexington Avenue, New York, New York 10017 (the "Grantee").

WHEREAS, the Grantor had granted to the Grantee a lien on and security interest in the trademarks and trademark licenses of the Grantor ("Trademark Collateral"), as described in the "Trademark Security Agreement – Short Form" executed between the Grantor and Grantee on April 11, 2002;

WHEREAS, the Grantor has fully satisfied its secured obligations to the Grantee and, thus, the parties desire to terminate the Grantee's security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby surrenders and relinquishes any and all rights, title and interest in and to the Trademark Collateral and the goodwill of the business associated with such Trademark Collateral, and requests that its security interest in such trademark Collateral be terminated and cancelled of record as of October 31, 2002.
