PATENT AND TRADEMARK SECURITY AGREEMENT

PATENT AND TRADEMARK SECURITY AGREEMENT, dated as of December 30, 2002, by ANDA, INC., a Florida corporation, ANDRX CORPORATION, a Florida corporation, ANDRX LABS, LLC, a Delaware limited liability company, ANDRX LABORATORIES, INC., a Mississippi corporation, ANDRX LABS, INC., a Florida corporation, ANDRX PHARMACEUTICALS, LLC, a Delaware limited liability company, CYBEAR, LLC, a Delaware limited liability company and MEDICONSULT.COM, INC., a Delaware corporation (collectively, the "Grantors," and each, individually, a "Grantor"), in favor of BANK OF AMERICA, N.A., with an office at 600 Peachtree Street, NE, Fifth Floor, Atlanta, Georgia 30308, in its capacity as Agent for Lenders (the "Agent").

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement dated as of the date hereof by and among Andrx Corporation, a Delaware corporation, as Parent Guarantor (the "Parent Guarantor"), certain direct and indirect Subsidiaries of the Parent Guarantor that are party thereto as Borrowers (collectively, the "Borrowers", and each, individually, a "Borrower"), certain other direct and indirect Subsidiaries of the Parent Guarantor party thereto as Guarantors (collectively, the "Guarantors", and each, individually, a "Guarantor"), the Agent and the Persons signatory thereto from time to time as Lenders (the "Lenders") (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement"), the Lenders have agreed to make the Revolving Loans and to provide other financial accommodations for the benefit of the Borrowers and guaranteed by the Parent Guarantor and the Guarantors;

WHEREAS, each Grantor is a party to the Credit Agreement, as either a Borrower or as a Guarantor;

WHEREAS, the Agent and the Lenders are willing to make the Revolving Loans and to provide the other financial accommodations as provided for in the Credit Agreement, but only upon the condition, among others, that each of the Grantors shall have executed and delivered to the Agent, for itself and the ratable benefit of the Lenders, this Patent and Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. DEFINED TERMS. The following terms shall have the following respective meanings:

"Patent" means all of the following in which any Grantor now holds or hereafter acquires any right, title or interest: (a) all patents of the United States or any other country, all registrations and recordings thereof, and all applications for patents of the United States or any other country, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State or Territory

thereof, or any other country; (b) all reissues, continuations, continuations-in-part or extensions thereof; and (c) all licenses, fees, royalties, damages or payments with respect to the foregoing.

“Patent Licenses” means rights under any written agreement now owned or hereafter acquired by any Grantor, as licensee, granting any right with respect to any invention on which a Patent is in existence.

“Trademark” means all of the following in which any Grantor now holds or hereafter acquires any right, title or interest: (a) all trademarks, trade names, corporate names, business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature (whether registered or unregistered), all registrations and recordings thereof, and all applications in connection therewith, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state or territory thereof, or any other country or any political subdivision thereof; (b) all reissues, extensions or renewals thereof; and (c) all licenses, fees, royalties, damages or payments with respect to the foregoing.

“Trademark Licenses” means rights under any written agreement now owned or hereafter acquired by any Grantor, as licensee, granting any right to use any Trademark.

All other capitalized terms used but not otherwise defined herein have the meanings given to them in Annex A thereto to the Credit Agreement.

2. GRANT OF SECURITY INTEREST IN PATENT AND TRADEMARK COLLATERAL. Each Grantor hereby grants to the Agent, on behalf of itself and the Lenders, a continuing first priority security interest in all of such Grantor’s right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the “Patent and Trademark Collateral”):

- (a) all of its Patents and Patent Licenses to which it is a party, including those referred to on Schedule I hereto;
- (b) all of its Trademarks and Trademark Licenses to which it is a party, including those referred to on Schedule II hereto;
- (c) all reissues, continuations or extensions of the foregoing;
- (d) all goodwill of the business connected with the use of, and symbolized by, each Patent, Patent License, Trademark and Trademark License; and
- (e) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future
 - (i) infringement of any Patent or Patent licensed under any Patent License,
 - (ii) infringement or dilution of any Trademark or Trademark licensed under any Trademark License, or
 - (iii) injury to the goodwill associated with any Patent, Patent licensed under any Patent License, Trademark, or Trademark licensed under any Trademark License.


3. SECURITY AGREEMENT. The security interests granted pursuant to this Patent and Trademark Security Agreement are granted in conjunction with the security interests granted to the Agent, on behalf of itself and the Lenders, pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Agent with respect to the security interest in the Patent and Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. NEW PATENT AND TRADEMARK COLLATERAL. If, prior to the termination of the Security Agreement, any Grantor shall (i) obtain rights to or become entitled to the benefit of any patent or patent application or any reissue, division, continuation, renewal, extension or continuation-in-part of any Patent or any improvement on any Patent, (ii) obtain rights to or become entitled to the benefit of any new trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks or service mark applications, (iii) obtain rights to or become entitled to the benefit of any new license agreements, whether as licensee or licensor, or license renewals, or (iv) enter into any new license agreement, the provisions of this Agreement shall automatically apply thereto (to the extent permitted by licensors under agreements in connection with the granting of any such licenses). Each Grantor hereby authorizes the Agent to modify this Agreement unilaterally (x) by amending Schedule I to include any future patents and patent applications that are Patents under this Agreement, or to include any future license agreements (to the extent permitted by licensors under agreements in connection with the granting of any such licenses) that are Patent Licenses under this Agreement, (y) by amending Schedule II to include any future trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks and service mark applications that are Trademarks under this Agreement, or to include any future license agreements (to the extent permitted by licensors under agreements in connection with the granting of any such licenses) that are Trademark Licenses under this Agreement, or (z) by filing, in addition to and not in substitution for this Agreement, a duplicate original of this Agreement containing on Schedule I thereto, as the case may be, such future patents, patent applications and future license agreements and containing on Schedule II thereto, as the case may be, such future trademarks, trade names, registered trademarks, trademark applications, service marks, registered service marks, service mark applications and future license agreements.
