- (1) CARL FREUDENBERG which is based at 69465 Weinheim, The Federal Republic of Germany ("the Assignor").
- (2) SIA FIBRAL LIMITED (Registered No. 02310364) whose registered office is at Radwinter Road, Saffron Walden, Essex, CB10 2LA ("the Assignee").

BACKGROUND

- (A) The Assignor is the registered proprietor of the registered trade marks detailed in Part A of the Schedule ("the Registered Trade Marks").
- (B) The Assignor has applied to register the trade marks detailed in Part B of the Schedule (the "Applications").
- (C) The Assignor has agreed to assign the Registered Trade Marks and the Applications (collectively called the "Trade Marks") together with the goodwill of the business of the Assignor relating to the goods or services in respect of which the Trade Marks are registered on the terms set out in this Agreement pursuant to the sale and purchase agreement between Freudenberg Limited (1) Asto Beteiligungs-GmbH (2) the Assignee (3) and Freudenberg & Co (4) ("the Sale and Purchase Agreement").

OPERATIVE PROVISIONS

In consideration of the payment of £1 (one pound) paid by the Assignee to the Assignor, receipt of which is hereby acknowledged, the Assignor assigns to the Assignee with full title guarantee the Trade Marks and the full and exclusive benefit of each of them, together with the goodwill of the business of the Assignor concerned in the goods or services in respect of which the Trade Marks are registered (or registration has been sought) pursuant to the Sale and Purchase Agreement, including all statutory and common law rights, and the right to sue for past infringements and to retain any damages obtained as a result of such action.

2. ASSIGNOR'S COVENANTS AND WARRANTIES

- The Assignor agrees at the expense of the Assignee to execute such further documents, and take such actions and do such things, as may be reasonably requested by the Assignee to give full effect to the terms of this Agreement and to secure the full right, title and interest of the Assignee in the Trade Marks.
- The Assignor warrants that:
 - 2.2.1 it is properly registered as the sole registered proprietor of the Trade Marks and is properly the sole applicant in the Applications;
 - 2.2.2 that the Trade Marks are valid and subsisting;

- 2.2.3 it has not done or omitted any act, matter or thing whereby the Trade Marks may be invalidated or refused in whole or in part, and is not aware of any reason that might result in such invalidation or refusal;
- 2.2.4 there is no subsisting licence under the Trade Marks;
- 2.2.5 it has not charged or encumbered any of the Trade Marks;
- 2.2.6 any renewal fee payable by the date of this Assignment in respect of the Trade Marks has been duly paid;
- it has not received any notice from any third party alleging infringement of 2.2.7 third party rights by use of the Trade Marks;
- 2.2.8 it is unaware of any infringement relating to the Trade Marks that is subsisting or that has occurred;
- 2.2.9 it will not itself use the Trade Marks after the date of this Agreement.
- 2.3 Any breach of the Warranties contained in clause 2.2 above shall be treated in accordance with clause 5 of the Sale and Purchase Agreement.

GOVERNING LAW AND JURISDICTION 3.

The formation, existence, construction, performance, validity and all aspects whatsoever of this Agreement or of any term of this Agreement shall be governed by English law. The English courts shall have non-exclusive jurisdiction to settle any disputes which may arise out of or in connection with this Agreement. The parties agree to submit to that jurisdiction.
