**AMENDED AND RESTATED
SUPPLEMENT TO INTELLECTUAL PROPERTY
SECURITY AGREEMENT (TRADEMARKS)**

WHEREAS, Smith Sport Optics, Inc., a Delaware corporation (herein referred to as "Grantor"), having an address at 280 Northwood Way, Ketchum, Idaho 83340 (1) has adopted, used and is using, or (2) has intended to use and filed an application indicating that intention, but has not yet filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, or (3) has filed an application based on an intention to use and has since used and has filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, the trademarks, trade names, trade styles and service marks listed on the annexed Schedule I-A, which trademarks, trade names, trade styles and service marks are registered in the United States Patent and Trademark Office (the "Trademarks"); and

WHEREAS, the Grantor entered into an Intellectual Property Security Agreement dated as of March 18, 2003 (the "Original Security Agreement") in favor of the Secured Party pursuant to which the Grantor granted to Secured Party a security interest in all right, title and interest of the Grantor in and to the Trademarks, together with all prints and labels on which said Trademarks have appeared or appear, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, and the goodwill of the business symbolized by the Trademarks and the applications, registrations and recordings in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any State thereof, or any other country or any political subdivision thereof, all whether now or hereafter owned or licensable by Grantor, and all reissues, extensions or renewals thereof, all Trademark Licenses and all proceeds of all of the foregoing, including, without limitation, any claims by Grantor against third parties for infringement thereof (the "Collateral"), to secure the payment and performance of the Secured Obligations.

WHEREAS, the security interest in the Collateral was submitted for recordation in the United States Patent and Trademark Office on March 19, 2003.

WHEREAS, the Original Security Agreement has been amended and restated pursuant to an Amended and Restated Intellectual Property Security Agreement dated as of ~~March 18~~^{May 13}, 2003 (the "Restated Security Agreement"; said Restated Security Agreement, as it may be hereafter amended, restated or otherwise modified from time to time, being the "Security Agreement", the terms defined herein being used herein as therein defined).

NOW, THEREFORE, for good and ~~valuable~~ consideration, receipt of which is hereby acknowledged, the Grantor does hereby further confirm, and put on the public record, its grant to Secured Party of a security interest in and mortgage on the Collateral to secure the prompt payment and performance of the Secured Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the grant of, security interest in and mortgage on the Collateral made hereby are more fully set forth in the Security Agreement; the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
