**AMENDED AND RESTATED
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*") dated February 25, 2003 is made by Xerium SA, a Luxembourg corporation ("*Luxco One*"), and certain of Luxco One's subsidiaries (together with Luxco One, the "*Grantors*"), to CIBC World Markets PLC, which has been appointed security agent (the "*Security Agent*") for the Senior Finance Parties and the Mezzanine Finance Parties pursuant to the Intercreditor Agreement.

WHEREAS, each Grantor has entered into a Security Agreement dated December 16, 2002 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Senior Security Agreement*"), and an Intellectual Property Security Agreement, dated December 16, 2002 ("*Senior IP Security Agreement*"), a true and correct copy of which is attached hereto as Exhibit A, with the Security Agent, pursuant to which each Grantor has granted to the Security Agent for its benefit and the ratable benefit of the Senior Finance Parties a security interest in all right, title, and interest to certain intellectual property rights of such Grantor.

WHEREAS, each Grantor has entered into a Mezzanine Security Agreement dated December 16, 2002 and amended and restated on February 25, 2003 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Mezzanine Security Agreement*"), with the Security Agent, pursuant to which each Grantor has granted to the Security Agent for its benefit and the ratable benefit of the Mezzanine Finance Parties a security interest in all right, title, and interest to certain intellectual property rights of such Grantor. Terms used herein and not otherwise defined herein shall have the meanings defined in the Senior Security Agreement and the Mezzanine Security Agreement.

WHEREAS, each Grantor has agreed to execute this IP Security Agreement, for recording with the U.S. Patent and Trademark Office and other governmental authorities, to amend and restate the Senior IP Security Agreement and to confirm the grant of the security interest granted to the Security Agent for its benefit and for the ratable benefit of the Senior Finance Parties and the Mezzanine Finance Parties under the Senior Security Agreement and the Mezzanine Security Agreement, respectively.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Grant of Security. Each Grantor hereby grants to the Security Agent for its benefit and for the ratable benefit of the Senior Finance Parties and the Mezzanine Finance Parties a security interest, and hereby confirms the grant of such security interest under the Senior Security Agreement and the Mezzanine Security Agreement, in and to all of the Grantor's right, title and interest in and to the following:

(a) The United States, international, and foreign patents, patent applications and patent licenses set forth on Schedule I hereto together with all reissues, divisions, continuations, continuations-in-part, extensions and reexaminations thereof, and all rights therein provided by international treaties or conventions (the "*Patents*");

(b) The United States and foreign trademark and service mark registrations, applications, and licenses set forth on Schedule II hereto (the "*Trademarks*");

(c) any and all claims for damages for past, present and future infringement, misappropriation or breach with respect to the Patents and Trademarks with the right, but not the obligation, to sue for and collect, or otherwise recover such damages; and

(d) any and all proceeds of the foregoing.


SECTION 2. Recordation. Each Grantor authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this IP Security Agreement.

SECTION 3. Execution in Counterparts. This IP Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.


SECTION 4. Governing Law. This IP Security Agreement shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, each Grantor has caused this IP Security Agreement to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.



INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*") dated December 16, 2002 is made by Xerium SA, a Luxembourg corporation ("*Luxco One*"), and certain of Luxco One's subsidiaries listed on Exhibit A hereto (together with Luxco One, the "*Grantors*"), to CIBC World Markets PLC, which has been appointed security agent (the "*Security Agent*") for the Senior Finance Parties pursuant to the Intercreditor Agreement.

WHEREAS, each Grantor has entered into a Security Agreement dated December 16, 2002 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*"), with the Security Agent. Terms defined in the Security Agreement and not otherwise defined herein shall have the meanings defined in the Security Agreement.

WHEREAS, each Grantor has granted to the Security Agent, under and subject to the terms of the Security Agreement, a security interest in all right, title, and interest to certain intellectual property rights of such Grantor, and has agreed to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

SECTION 1. Grant of Security. Each Grantor hereby grants to the Security Agent for its benefit and for the ratable benefit of the Senior Finance Parties a security interest in and to all of the Grantor's right, title and interest in and to the following:

(e) The United States, international, and foreign patents, patent applications and patent licenses set forth on Schedule I hereto together with all reissues, divisions, continuations, continuations-in-part, extensions and reexaminations thereof, and all rights therein provided by international treaties or conventions (the "*Patents*");

(f) The United States and foreign trademark and service mark registrations, applications, and licenses set forth on Schedule II hereto (the "*Trademarks*");

(g) any and all claims for damages for past, present and future infringement, misappropriation or breach with respect to the Patents and Trademarks with the right, but not the obligation, to sue for and collect, or otherwise recover such damages; and


(h) any and all proceeds of the foregoing.






