TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") dated as of December 31, 2002 (the "Effective Date"), is made by and between LTV Steel Company, Inc., a New Jersey corporation ("Assignor"), and Maverick C&P, Inc., a Delaware corporation ("Assignee").

BACKGROUND INFORMATION

A. Assignee, the permitted assignee of Maverick Tube Corporation, is a party to that certain Asset Purchase Agreement, dated as of October 15, 2002 ("Purchase Agreement"), by and among the LTV Corporation, a Delaware corporation, Assignor, Georgia Tubing Corporation, a Delaware corporation, and Assignee, pursuant to which Assignor agreed to sell and Assignee agreed to purchase substantially all of the assets, properties, rights and interests relating to the LTV Tubular Business as defined in the Purchase Agreement, including, without limitation, the servicemarks, trademarks and trade names of Assignor; and

B. Assignor has adopted, used, is using and is the owner of the United States trademarks now registered in the United States Patent and Trademark Office identified on Schedule A (the "Trademarks"); and

C. Assignee wishes to acquire and Assignor wishes to assign all right, title and interest in and to the Trademarks together with the goodwill of the business in connection with which the Trademarks are used; and

D. Assignee has succeeded to the business, assets and appurtenant goodwill of Assignor.

STATEMENT OF AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby assigns to Assignee all right, title and interest in and to the Trademarks, and the registrations therefor, together with the goodwill of the business symbolized by the Trademarks and the registrations thereof. This assignment is for Assignee's own use, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Trademarks, with the right to sue for and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.
