GRANT OF SECURITY INTEREST IN TRADEMARKS

This GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of April 9, 2003, is made by SNORKEL HOLDINGS, LLC, a Kansas limited liability company, HBWP, INC., a Delaware corporation, and SNORKEL INTERNATIONAL, INC., a Delaware corporation, having their principal offices located at 1609 Roseport Road, Elwood, Kansas 66024 (collectively, jointly and severally, "Grantor"), and in favor of LASALLE BUSINESS CREDIT, LLC, a Delaware limited liability company, having its principal offices located at 135 South LaSalle Street, Suite 425, Chicago, Illinois 60603 ("Grantee").

RECITALS

WHEREAS, Grantor is the owner of all right, title and interest in and to the trademark registrations and applications for registration set forth on Schedule A attached hereto, including all goodwill associated therewith and all statutory and common law rights therein (the "Trademarks"); and

WHEREAS, Grantor and Grantee are parties to that certain Loan and Security Agreement dated as of even date herewith (as amended, restated, extended, modified or supplemented from time to time (the "Loan Agreement")); and

WHEREAS, as a condition of the Loan Agreement, Grantor desires to grant a security interest in, and a lien upon, all of Grantor's right, title and interest in and to the Trademarks to Grantee.

AGREEMENT

NOW, THEREFORE, in consideration of the premises and mutual agreements herein set forth and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Subject to the terms and conditions of the Loan Agreement, Grantor hereby assigns and grants to Grantee a first security interest in, and a lien upon, all of Grantor's right, title and interest in and to (i) all of Grantor's worldwide rights, title and interest in, to and under the Trademarks, and any and all goodwill associated therewith; (ii) all Proceeds (as such term is defined in the Loan Agreement) and products of the Trademarks, (iii) all of the goodwill of the businesses with which the Trademarks are associated and (iv) all causes of action, past, present and future, for infringement, misappropriation, or dilution of any of the Trademarks or unfair competition regarding the same.

2. This grant is made to secure the satisfactory performance and payment of all the Liabilities (as such term is defined in the Loan Agreement) of Grantor and shall be effective as of the date of the Loan Agreement.

3. This grant has been granted in conjunction with the security interest granted to Grantee under the Loan Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Loan Agreement, all terms and provisions of which are incorporated herein

by reference. In the event that any provisions of this Grant of Security Interest in Trademarks are deemed to conflict with the Loan Agreement, the provisions of the Loan Agreement shall govern.
