A special meeting of the Sole Shareholder of Enrich International, Inc. was held on February 27, 2001 at the corporate offices located at Corporate Business Control, Rokkereenseweg 49, 2712 PJ Zoetermeer The Netherlands.

It was proposed that the name of the Corporation, Enrich International, Inc., be changed to Unicity Network, Inc. The Sole Shareholder, Nutricia Utah, L.P., a Utah Limited Partnership, representing all 12,327,615 issued and outstanding common shares of the Company voted in favor of the proposal to change the company name and amend the articles giving sufficient approval to adopt the amendment of the articles and therefore it was:
