

2. During the deliberations of the General Mixed Ordinary and Extraordinary Meeting of REGIE NATIONALE DES USINES RENAULT that took place on October 26, 1995, different statutory modifications were adopted and, in particular, the Company has substituted its name « REGIE NATIONALE DES USINES RENAULT » by « RENAULT ». It is understood that « Société Anonyme » corresponds to the legal form of the Company.
3. During the deliberations of the General Ordinary Meeting of RENAULT that took place on June 8, 2000 different statutory modifications were adopted and in particular, as from January 1st 2000, the head office of RENAULT has moved from 34 quai du Point du Jour, 92100 Boulogne-Billancourt to 13/15 quai Le Gallo, 92100 Boulogne-Billancourt.
4. During the deliberations of Extraordinary General Meeting of RENAULT that took place on March 28th, 2002 different statutory modifications were adopted and in particular, the transfer as partial contribution of assets between RENAULT and RENAULT s.a.s. pursuant to which the elements of assets of RENAULT (including the trademarks, patents and designs) have been assigned to RENAULT s.a.s..

RENAULT s.a.s. is a French *société par actions simplifiée* registered in the Nanterre (France) Trade and Companies Register under the number B 780 129 987 and which head office is located in Boulogne-Billancourt (92100).
