**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

TERMINATION AND RELEASE, dated as of October 22, 2003, from Wachovia Bank, National Association (the "Secured Party"), a national banking association organized under the laws of the United States of America, to Homelite Technologies, Ltd. (the "Pledgor"), a company incorporated under the laws of Bermuda.

WITNESSETH:

WHEREAS, pursuant to a Security Agreement by and among the Pledgor, the Secured Party and others dated as of October 21, 2002, the Pledgor granted a security interest (the "Security Interest") in certain Collateral (as hereinafter defined) to the Secured Party, in its capacity as agent for certain lenders, as security for certain loans (the "Loans") agreed to be advanced to Homelite Consumer Products, Inc. pursuant to a revolving and term loan agreement dated as of October 21, 2002; and

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent & Trademark Office on October 22, 2002, at Reel 002610, Frame 0121; and

WHEREAS, the Loans have now been satisfied and the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration including the repayment of the Loans secured by the Collateral, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby terminates and releases the Security Interest in the Collateral as follows:

Collateral: The term "Collateral," as herein, shall mean all of the Pledgor's right, title and interest of every kind and nature in:

(a) the United States trademarks and service marks set forth on Schedule A attached hereto and (i) all registrations, applications, recordings and common-law rights relating thereto; (ii) all renewals thereof, (iii) all income, license royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past, present and/or future infringements thereof; (iv) the right to sue for past, present and future infringements thereof; (v) all rights and remedies corresponding thereto throughout the world; and (vi) the goodwill of Pledgor's business connected with and symbolized by the foregoing; and

IN WITNESS WHEREOF, the undersigned has executed this Termination and Release by its duly authorized officer as of the date first above written.
