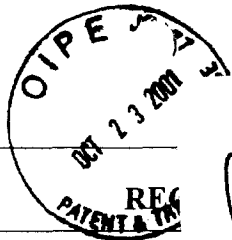

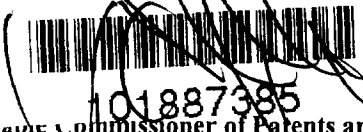



However, inadvertently, the "CO." was omitted from the new name on the original transmittal letter. A copy of the Change of Name document, which correctly reflects the name change, is also attached.


