## TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of July 31, 2003, by and between the Grantor identified as such on the signature page hereof (the "Grantor"), in favor of GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, as North American collateral agent ("North American Collateral Agent") for the Secured Parties (as defined below).

### W I T N E S S E T H:

WHEREAS, pursuant to that certain Credit Agreement dated as of the date hereof by and among the U.S. Borrower (as defined therein), the European Borrower (as defined therein), the other Credit Parties (as defined therein) parties thereto, Lenders (as defined therein) ("Working Capital Lenders"), General Electric Capital Corporation, for itself, as Agent for Working Capital Lenders (in such capacity, the "Agent") and as North American Collateral Agent, and KBC Bank NV, individually as Fronting Lender (as defined therein) and as European Agent (as defined therein) ("European Agent") (including all annexes, exhibits and schedules thereto, as from time to time amended, restated, replaced, refinanced, supplemented, or otherwise modified, the "Credit Agreement"), Working Capital Lenders have agreed to make the Loans (as defined therein) and to incur Letter of Credit Obligations (as defined therein) on behalf of the Borrowers (as defined therein);

WHEREAS, one or more of the U.S. Borrower's retirement plans subject to Title IV of the Employee Retirement Income Security Act of 1974, as amended, has or may have Unfunded Pension Liabilities as a result of which the U.S. Borrower or the Grantor may potentially become subject to certain claims of the Pension Benefit Guaranty Corporation ("PBGC");

WHEREAS, pursuant to the Amendment and Restatement of Term Sheet, dated July 23, 2003 (the "PBGC Agreement"), between PBGC and the U.S. Borrower, the U.S. Borrower has agreed that, if certain U.S. Grantors (as such term is defined in the Security Agreement as defined herein) (including the Grantor) grant a lien on or security interest in any of the Trademark Collateral (as defined below) as security for such U.S. Grantor's Working Capital Obligations (as defined below) to the Working Capital Lenders and the Agent under or in respect of the Credit Agreement and the Domestic Subsidiary Guaranty (as defined in the Credit Agreement) executed by such U.S. Grantor in connection therewith, the U.S. Borrower will, and will cause such U.S. Grantor to, grant in favor of PBGC, as security for the PBGC Claim (as defined in the Collateral Agency Agreement referenced below), an equal and ratable lien on and security interest in such Collateral;

WHEREAS, in order to induce North American Collateral Agent and Working Capital Lenders to enter into the Credit Agreement and other Loan Documents (as defined in the Credit Agreement) and to induce Working Capital Lenders to make the Loans and to incur Letter of Credit Obligations as provided for in the Credit Agreement, the U.S. Grantors have executed and delivered that certain Security Agreement dated as of the date herewith (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or

otherwise modified, the “Security Agreement”) to North American Collateral Agent, for itself and the benefit of the other Secured Parties;

WHEREAS, pursuant to the Security Agreement, U.S. Grantor are required to execute and deliver to North American Collateral Agent, for itself and the benefit of Secured Parties, this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

1. DEFINED TERMS.

(a) All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement or in Annex A thereto.

(b) “Collateral Agency Agreement” means that certain Collateral Agency Agreement dated as of the Closing Date by and among the Agent (as defined therein), the North American Collateral Agent (as defined therein), Domestic Borrower (as defined therein) and the other Domestic Companies (as defined therein).

(c) “PBGC Claim” has the meaning set forth in the Collateral Agency Agreement.

(d) “Secured Obligations” means the Working Capital Obligations and the PBGC Claim.

(e) “Secured Parties” means the North American Collateral Agent, the Agent, the European Agent, Working Capital Lenders and PBGC.

(f) “Working Capital Obligations” means “Obligations” as defined in the Credit Agreement.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. To secure the prompt and complete payment, performance and observance of all of the Secured Obligations, in furtherance of and in addition to the provisions of the Security Agreement, Grantor hereby grants, assigns, conveys, mortgages, pledges, hypothecates and transfers to North American Collateral Agent, for the benefit of itself and the other Secured Parties, a security interest in and continuing lien upon all of the Grantor’s right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the “Trademark Collateral”):

(a) all of its Trademarks listed on Schedule I hereto;

(b) all renewals of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each Trademark listed on Schedule I; and

(d) all products and Proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark listed on Schedule I or (ii) injury to the goodwill associated with any Trademark listed on Schedule I hereto.

3. SECURITY AGREEMENT. The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to North American Collateral Agent, on behalf of itself and Secured Parties, pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of North American Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. RELEASE OF SECURITY INTEREST. Upon the termination of the Security Agreement pursuant to Section 15 thereof and/or as otherwise required by the Loan Documents, the North American Collateral Agent shall, upon Grantor's request, release Liens on the Trademark Collateral and execute and deliver to Grantor all instruments and other document necessary or appropriate to release the Liens on, and security interests in, the Trademark Collateral which has been granted hereunder and shall reassign all right, title and interest in the Trademark Collateral to the Grantor.

5. LOAN DOCUMENT, ETC. This Trademark Security Agreement is a Loan Document executed pursuant to the Credit Agreement and shall (unless otherwise expressly indicated herein) be construed, administered and applied in accordance with the terms and provisions of the Credit Agreement. In the event of an irreconcilable conflict between this Trademark Security Agreement and the Security Agreement, the Security Agreement shall govern.




