**ARTICLES OF MERGER
MERGING
BETZDEARBORN HYDROCARBON PROCESS GROUP INC.,
A TEXAS CORPORATION,
WITH AND INTO
BETZDEARBORN INC.,
A PENNSYLVANIA CORPORATION**

Pursuant to the provisions of Section 1926 of the Pennsylvania Business Corporation Law, BetzDearborn Inc., a Pennsylvania corporation ("Parent"), is adopting the following Articles of Merger for the purpose of merging BetzDearborn Hydrocarbon Process Group Inc., a Texas corporation ("Subsidiary"), with and into Parent (the "Merger").


1. Parent owns 100% of all issued and outstanding capital stock of Subsidiary. The Board of Directors of Parent adopted an Agreement and Plan of Merger (the "Plan") for the merger of Subsidiary into Parent. Under the Plan, Subsidiary will merge with and into Parent and with Parent being the surviving corporation (the "Surviving Corporation") in the Merger. The name of the Surviving Corporation will be "BetzDearborn Inc."
2. The Surviving Corporation is a domestic business corporation and the address of its current registered office in this Commonwealth is 4636 Somerton Road, Trevose, Pennsylvania USA 19053.
3. The manner in which the Plan was adopted by Parent is as follows: adoption by the Board of Directors of Parent pursuant to Section 1924(b)(3) of the PBCL.
4. The Plan was authorized, adopted and approved, as the case may be, by the Subsidiary in accordance with the laws of the jurisdiction in which it is incorporated.
5. The articles of incorporation of the Surviving Corporation shall be the articles of incorporation of Parent without any amendment thereto.
6. The full text of the Plan is on file at the principal place of business of the Surviving Corporation, the address of which is 4636 Somerton Road, Trevose, Pennsylvania 19053.
7. The Merger shall be effective as of 11:59 p.m. on December 31, 1998.
