# TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE dated as of August 8, 2003, from Morgan Stanley Senior Funding, Inc. as Administrative Agent, a national banking corporation located at 1585 Broadway, New York, NY 10036 (the "Administrative Agent"), to Graphic Packaging Corporation (the "Grantor"), a Delaware corporation with its principal place of business located at 4455 Table Mountain Drive, Golden, Colorado 80403 (capitalized terms used herein without definition are used as defined in the Credit Agreement, dated as of February 28, 2002, among the Grantor, the Parent, the Lenders, Credit Suisse First Boston and the Administrative Agent).

#### WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of February 28, 2002, made by the Grantor in favor of the Administrative Agent (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), a security interest (the "Security Interest") was granted by the Grantor to the Administrative Agent in certain Trademark Collateral (as hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on March 20, 2002, at Reel 2467, Frame 0332; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

- 1. <u>Trademark Collateral</u>: The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature in:
- (a) (i) all of its trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos and other source or business identifiers, and all goodwill of the business associated therewith, now existing or hereafter adopted or acquired including those referred to in <u>Schedule A</u> hereto, whether currently in use or not, all registrations and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and

applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any other country or political subdivision thereof or otherwise, and all common-law rights relating to the foregoing, and (ii) the right to obtain all reissues, extensions or renewals of the foregoing (collectively referred to as the "Trademark");

- (b) all of the goodwill of the business connected with the use of, and symbolized by the items described in, clause (a), and to the extent applicable clause (b);
- (c) the right to sue third parties for past, present and future infringements of any Trademark Collateral described in clause (a) and, to the extent applicable, clause (b); and
- (d) all proceeds of, and rights associated with, the foregoing, including any claim by the Grantor against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license, or for any injury to the goodwill associated with the use such Trademark or for breach or enforcement of any Trademark license and all rights corresponding thereto throughout the world.
- 2. <u>Release of Security Interest</u>: The Administrative Agent, hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void.
