TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made and entered into as of the 6th day of February, 2004.

BETWEEN: **Sassaby, LLC** (formerly known as Sassaby, Inc.), a Delaware limited liability company
(the "Assignor")
-and-
Jane & Company, LLC, a Delaware limited liability company
(the "Assignee").

WHEREAS, pursuant to a certain Asset Purchase Agreement dated as of February 6, 2004, by and among The Estée Lauder Companies Inc., the Assignor, Sassaby Cosmetics, LLC and the Assignee (the "**Asset Purchase Agreement**"), wherein the Assignor agreed, inter alia, to sell, convey, assign, transfer and deliver to the Assignee various items of Intellectual Property (as defined in the Asset Purchase Agreement); and

WHEREAS, among the items of Intellectual Property to be assigned to Assignee were certain trademarks owned by Assignor, and any trademark registrations and applications therefor or with respect thereto, all as set forth on Schedule 1.1.24 to the Asset Purchase Agreement, a copy of which is annexed hereto as Exhibit A.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor is the owner of certain trademarks and service marks, including certain registrations therefor or applications with respect thereto, all as set forth on Exhibit A annexed hereto (referred to collectively as the "**Trademarks**").
2. Assignor hereby irrevocably sells, conveys, assigns, transfers and delivers unto the Assignee, its successors and assigns, all of its right, title and interest in and to the Trademarks, including, without limitation, any registrations therefor or applications with respect thereto, all as set forth on Exhibit A; all of the good will of Assignor's respective businesses associated with or symbolized by the Trademarks; and all of Assignor's rights, if any, to sue for or make claims with respect to any past, present or future infringement of the Trademarks.

3. This Trademark Assignment is subject to all licenses and other rights in and to the Trademarks previously granted to any third person and listed on Schedule 4.9 to the Asset Purchase Agreement with the exception of any such license or agreement marked as "Retained Assets/Retained Liabilities", which grants are in effect as of the date of this Trademark Assignment.

4. Pursuant to a certain Domain Name Assignment entered into on February 6, 2004, certain domain names were assigned to Assignee by Assignor and various Affiliates (as defined in the Asset Purchase Agreement) of Assignor. Pursuant to the Asset Purchase Agreement, Assignor hereby irrevocably sells, conveys, assigns, transfers and delivers unto the Assignee any and all trademark rights it has or may have in or to such domain names, to the extent they or any of them have been used or have otherwise served as trademarks, together with all the good will of Assignor's business associated with or symbolized by any such domain names.



6. This Trademark Assignment shall be governed by and construed in accordance with the laws of the State of New York without regard to the conflicts of law principles thereof.
