**MEMORANDUM OF LICENSE AGREEMENT**

**WHEREAS**, 7-Eleven, Inc., formerly known as The Southland Corporation, of 2711 North Haskell Avenue, Dallas, Texas 75204 ("SEI"), has adopted and is using the trademarks and service marks more particularly described in Exhibit "A" attached hereto (collectively, "Marks");

**WHEREAS**, SEI has, pursuant to that certain Amendment to Area License Agreement dated \_\_\_\_\_, 2003, between Seven-Eleven Japan Co., Ltd. ("SEJ") and SEI ("License Agreement"), granted to SEJ a perpetual license for the exclusive use of the Marks in the State of Hawaii ("Territory") in connection with those certain retail stores identified principally by the trade name and mark "7-Eleven" ("7-Eleven Stores") and the products and services made available therefrom; and

**WHEREAS**, SEI and SEJ desire to make the license granted under the License Agreement of public record.

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, the parties hereto hereby acknowledge and agree as follows:

1. SEI has granted to SEJ, pursuant to the License Agreement, a perpetual license for the use of the Marks in the Territory in connection with the 7- Eleven Stores and the products and services made available therefrom.

2. An exception to SEI's exclusive use of the Marks throughout the United States will be rights secured to SEJ by the License Agreement.

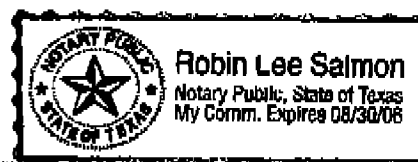
