RELEASE OF LIEN IN TRADEMARKS

This RELEASE OF LIEN IN TRADEMARKS is given as of this 23rd day of March 2004 by Bank of America, N.A., a national banking association, located at 335 Madison Avenue, New York, New York (as successor in interest to Bankers Trust Company), as Collateral Agent for the Secured Creditors ("Assignor"), in favor of Sweetheart Cup Company, Inc., a Delaware corporation, located at 10100 Reisterstown Road, Owings Mills, Maryland 21117 ("Assignee"), the successor-in-interest to Fort Howard Cup Company. Capitalized terms not defined herein shall have the meanings set forth in the Security Agreement (as defined below).

WHEREAS, pursuant to a Security Agreement dated as of November 14, 1989 between Assignor and Fort Howard Cup Company (the "Security Agreement"), Fort Howard Cup Company (now known as Sweetheart Cup Company Inc.) granted a security interest in all of its right, title and interest in and to all Marks (defined as any trademarks and service marks now held or hereafter acquired by Fort Howard Cup Company which are registered in the United States Patent and Trademark Office, including but not limited to the trademarks and service marks on Schedule A hereto as well as any unregistered marks used by Fort Howard Cup Company in the United States or Canada, and all trade dress including logos and/or designs in connection with which any of these registered or unregistered marks are used), registrations and rights to renewals thereof, and the goodwill of the business symbolized by the Marks (collectively, the "Trademark Collateral"), to secure the payment and performance of all of the Obligations.

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on February 13, 1990 at Reel 0763/Frame 0091; and

WHEREAS, Assignee has satisfactorily paid and performed all of its Obligations and Assignor desires to release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in the Trademark Collateral to Assignee and, without representation, warranty or recourse of any kind, reverts Assignee with full title to the Trademark Collateral.
