**TERMINATION
OF
SECURITY INTEREST IN TRADEMARKS**

This Termination of Security Interest in Trademarks (the "Termination") is executed on behalf of LaSalle Business Credit, LLC (successor by merger to LaSalle Business Credit, Inc.), as Collateral Agent (the "Collateral Agent"), in favor of Sanmina-SCI Corporation, a Delaware corporation ("Sanmina"), and its subsidiaries, as set forth on Exhibit A attached hereto (together with Sanmina, collectively referred to as the "Debtors"), and is effective as of September 22, 2003.

RECITALS

The Secured Party therefore expressly terminates its security interest in the Collateral, including without limitation, the trademarks and trademark applications listed on Schedule 1-A and 1-B attached hereto.
