

NOW, THEREFORE, for \$1.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, Assignor hereby assigns to Assignee, its successors, legal representatives and assigns, the entire right, title, and interest of Assignor in and to the Marks, together with the goodwill of the business connected with the use of and symbolized by the Marks, and all claims, if any, which may have arisen thereunder prior to the date of this instrument.
