Pursuant to the provisions of the Colorado Business Corporation Act, the domestic business corporation and the foreign business corporation herein named do hereby submit the following Articles of Merger.

1. Annexed hereto and made a part hereof is the Plan of Merger for merging Promotional Tours Travel Marketing, Inc., a New York corporation ("Promotional"), with and into Syncorp, Inc., a Colorado corporation ("Syncorp"), as approved by resolution adopted at a meeting by the Board of Directors of Promotional on November 21, 2000 and by resolution adopted at a meeting by the Board of Directors of Syncorp on November 21, 2000.
