## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "<u>Assignment</u>") is made and entered into this 28th day of October, 2003, by and among FARMLAND INDUSTRIES, INC., a Kansas cooperative corporation ("<u>Industries</u>"), FARMLAND FOODS, INC., a Kansas corporation ("<u>Foods</u>"), both Debtors-in-Possession (Industries and Foods are collectively referred to hereafter as "<u>Assignor</u>"), and SF INVESTMENTS, INC., a Delaware corporation ("<u>Assignee</u>").

## WITNESSETH:

WHEREAS, Foods, a subsidiary of Industries, is an integrated pork-processing company which sells fresh and processed pork into retail, foodservice, industrial and international channels (the "Business");

WHEREAS, Assignor is the owner of certain trademarks, service marks, trade names, trademark registrations and trademark applications listed on Exhibit A attached hereto and by this reference made a part hereof but excluding the Rejected Contracts and any contract or agreement constituting an Excluded Asset (collectively the "Marks");

WHEREAS, Assignor is transferring the Transferred Assets to KC Acquisition, Inc., a Delaware corporation, or its designees, pursuant to that certain Amended and Restated Asset Sale and Purchase Agreement ("Asset Purchase Agreement") dated October 12, 2003, and in connection therewith, Assignor desires to assign each of the Marks to Assignee and Assignee desires to accept such assignment and to acquire all right, title and interest of Assignor in and to the Marks, together with the goodwill of the business in connection with which the Marks are used; and

WHEREAS, in accordance with Section 4.2(a) of the Asset Purchase Agreement, Buyer has designated Assignee, an Affiliate of Buyer, as its designee, to accept the assignment of the Marks;

NOW, THEREFORE, in consideration of the premises, the mutual covenants and agreements stated herein and other good and valuable consideration, receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. <u>Assignment</u>. As of the date hereof, Assignor hereby irrevocably assigns, transfers, conveys and delivers to Assignee, its successors and assigns, absolutely and forever, all of Assignor's right, title and interest, whether statutory or at common law, in and to the Marks, together with the goodwill of the business symbolized by the Marks throughout the world, and all registrations and pending applications therefor, in all countries throughout the world, together with all right, title and interest of Assignor in and to all causes of action for any and all previously occurring infringement of the rights being assigned and the right to receive and retain the proceeds or other remedies relating to those infringements.

- 2. <u>Acceptance</u>. As of the date hereof, Assignee hereby accepts the foregoing assignment.
- 3. <u>Further Assurances</u>. Assignor agrees to execute such further assignments and documents and to do such other acts as may be necessary or reasonably desirable to vest all of Assignor's right, title and interest in and to the Marks throughout the world in Assignee or as may be necessary or reasonably desirable to obtain, renew, or issue the Marks, including, without limitation, execution of powers of attorney as reasonably necessary and requested by foreign agents to record this Assignment and transfer the Marks on the records of trademark offices throughout the world.
- 4. Governing Law. This Assignment shall be governed by and construed and interpreted in accordance with the Laws of the State of Missouri applicable to agreements made and to be performed entirely within such state, including all matters of construction, validity and performance.
- 5. Jurisdiction. During the Bankruptcy Cases, any suit, action or proceeding between the parties hereto relating to this Assignment or to any agreement, document or instrument delivered pursuant hereto or in connection with the transactions contemplated hereby, or in any other manner arising out of or relating to the transactions contemplated by or referenced in this Assignment shall be commenced and maintained exclusively in the Bankruptcy Court. The parties hereto submit themselves unconditionally and irrevocably to the personal jurisdiction of such court. Subsequent to the Bankruptcy Cases, any suit, action or proceeding between the parties hereto relating to this Assignment or to any agreement, document or instrument delivered pursuant hereto or in connection with the transactions contemplated hereby, or in any other manner arising out of or relating to the transactions contemplated by or referenced in this Assignment shall be commenced and maintained exclusively in the United States District Court for the Western District of Missouri, or if that court lacks jurisdiction over the subject matter, in a state court of competent subject matter jurisdiction sitting in Platte County, Missouri. The parties hereto submit themselves unconditionally and irrevocably to the personal jurisdiction of such courts, as applicable. The parties further agree that venue shall be in Western District of Missouri. The parties hereto irrevocably waive any objection to such personal jurisdiction or venue, including, but not limited to, the objection that any suit, action or proceeding brought in Western District of Missouri, has been brought in an inconvenient forum.
- 6. <u>Counterpart</u>. This Assignment may be executed in one or more counterparts each of which shall be deemed an original but all of which together shall constitute but one and the same instrument.
- 7. Miscellaneous. This Assignment is made in accordance with the terms of the Asset Purchase Agreement and is subject to the terms, conditions, and limitations set forth in the Asset Purchase Agreement, the provisions of which are incorporated herein by reference; as designee of Buyer under the Asset Purchase Agreement, the rights of Assignee under this Assignment shall be no greater than would be the rights of Buyer if Buyer were the assignee hereunder in lieu of Assignee, and the obligations of Assignor under this Assignment shall be no greater than would be the obligations of Assignor if Buyer were the assignee hereunder in lieu of
