ASSIGNMENT OF SECURITY INTEREST

THIS ASSIGNMENT OF SECURITY INTEREST, dated as of November 14, 2003, is entered into between FEDERAL DEPOSIT INSURANCE CORPORATION in its Capacity as Receiver of Southern Pacific Bank dba Coast Business Credit ("the FDIC"), having an address, for purposes of this Assignment only, of 1910 Pacific Avenue, Suite 1200, Dallas, Texas 75201 and WAMCO 31, Ltd. ("Wamco"), c/o First City Servicing Corporation, 6400 Imperial Drive, Waco, TX 76712.

WHEREAS Martin Color-Fi, Inc. ("Martin"), a South Carolina corporation, granted a security interest to Coast Business Credit, a division of Southern Pacific Bank, in and to "each of the material trademarks and rights and interests which are capable of being protected as trademarks, which are presently, or in the future may be, owned, created, acquired, or used by [Martin], in whole or in part, and all trademark rights with respect thereto throughout the world, including all proceeds thereof, and rights to renew and extend such material trademarks and trademark rights," and all goodwill associated therewith, including but not limited to the United States trademark applications and registrations listed in Schedule A (collectively referred to as "Trademark Rights, Applications and Registrations") (appended hereto as Exhibit A), as set forth in the Patent and Trademark Security Agreement dated October 2, 2002 ("Security Interest"); and

WHEREAS the FDIC has granted a power of attorney to James C. Holmes, Executive Vice President; Kathy S. McNair, Sr. Vice President; Stephen C. Gohring, Vice President; and Nancy D. Walker, Assistant Vice President, on its behalf (attached as Exhibit B).
