RELEASE OF LIEN ON TRADEMARKS

THIS RELEASE OF LIEN ON TRADEMARKS, is made and entered into this 16 day of Aug, 2004 (the "Release") by and between PLAYCORE HOLDINGS, INC., a Delaware corporation ("PlayCore Holdings"), PS COMMERCIAL PLAY, LLC, a Delaware limited liability company ("PS Commercial"), and PLAYCORE WISCONSIN, INC., a Wisconsin corporation ("Borrower" and collectively with PlayCore Holdings and PS Commercial, the "Grantors") and GENERAL ELECTRIC CAPITAL CORPORATION, a New York corporation, in its capacity as Administrative Agent for Lenders.

WITNESSETH:

WHEREAS, the Grantors, Playcore, Inc. (a Delaware corporation which since merged into PlayCore Holdings), Administrative Agent, Documentation Agent and the Persons signatory thereto from time to time as Lenders entered into that certain Amended and Restated Credit Agreement dated as of May 19, 2000 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement");

WHEREAS, pursuant to the Credit Agreement and to secure the performance of certain obligations (the "Obligations"), the Grantors and the Administrative Agent entered into that certain Security Agreement dated as of May 19, 2000; New Holdings, Borrower and Administrative Agent entered into that certain Trademark Security Agreement dated as of May 19, 2000 (collectively, the "2000 Trademark Security Agreements"); PS Commercial and Administrative Agent entered into that certain Trademark Security Agreement dated as of January 6, 2003 ("2003 Trademark Security Agreement");

WHEREAS, pursuant to the that certain Credit Agreement dated April 23, 2003 by and among Borrower, PS Commercial and Heartland Industries, Inc. (DE), a Delaware corporation, ("Heartland"), other Credit Parties signatory thereto and Administrative Agent as Lender, Borrower, PS Commercial and Heartland and Administrative Agent entered into that certain Second Lien Trademark Security Agreement dated April 23, 2004 (collectively with the 2000 Trademark Security Agreements and the 2003 Trademark Security Agreement, the "Trademark Security Agreements");

WHEREAS, pursuant to the Trademark Security Agreements, the Grantors granted the Administrative Agent a security interest in the specific intellectual property set forth on Schedule A annexed hereto (the "Released Trademarks");

WHEREAS, the Trademark Security Agreements were recorded in favor of the Administrative Agent with the United States Patent and Trademark Office on Reel 2112, Frame 0169; Reel 2651, Frame 0301; and Reel 2798, Frame 0858; and

WHEREAS, the Obligations have now been satisfied, the Grantors have requested that the Administrative Agent release any and all interest it may have in the Released Trademarks, and the Administrative Agent has agreed to do so.


NOW THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties to this Release intending to be legally bound agree as follows:

1. The Administrative Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.
2. All capitalized terms used herein but not otherwise defined shall have the meanings given to them in Annex A to the Credit Agreement.
3. The parties hereto authorize and request the Commissioner of Patents and Trademarks of the United States to record this Release against the Released Trademarks.
4. This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to the conflict of law principles thereof.
5. This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.
6. All rights hereunder shall accrue to, and all obligations hereunder shall be binding upon, the heirs, representatives, successors, assigns and transferees of the parties hereto.
7. This Release may be executed in any number of separate counterparts, each of which, when so executed, shall be deemed an original, and all of said counterparts taken together shall be deemed to constitute but one and the same instrument.




