**COLLATERAL ASSIGNMENT OF SECURITY INTEREST IN  
TRADEMARKS AND LICENSES**

**THIS COLLATERAL ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS AND LICENSES** (this "Agreement") is made as of February 9, 2004, by **MANSFIELD PLUMBING PRODUCTS LLC**, a Delaware limited liability company, having an office at 150 East First Street, P.O. Box 620, Perrysville, OH 44864 ("Grantor") in favor of **BANK ONE, NA**, a national banking association, having an office at 50 S. Main Street Akron, Ohio 44321 in its capacity as agent (the "Agent") to the lenders ("Lenders") party to the Credit Agreement referred to below.

**RECITALS**

A. The Agent, as lender, and the Lenders have made or will make one or more loans or advances pursuant to that certain Credit Agreement, dated as of the date hereof (as amended, restated or otherwise supplemented from time to time, the "Credit Agreement"; capitalized terms used herein and not otherwise defined herein shall have meanings attributed to them in the Credit Agreement), between the Grantor, as borrower, and the Agent, as agent and as lender, which loans and advances are secured in whole or in part by the Pledge and Security Agreement, between the Grantor and the Agent for the Lenders includes the grant of a security interest in the Collateral.

B. Pursuant to the Pledge and Security Agreement, Grantor has agreed to grant the Agent a security interest in all of its right, title and interest in and to the trademarks listed on Exhibit A hereto and incorporated herein by reference and the goodwill symbolized by such trademarks (the "Goodwill") as collateral security for the Obligations (as defined in the Credit Agreement).

D. Except as otherwise described in Section 3.10 of the Pledge and Security Agreement, Grantor is the owner of the right, title and interest in the trademarks listed on Exhibit A hereto and the Goodwill.

**NOW, THEREFORE**, in consideration of the foregoing and other good and valuable consideration, Grantor hereby:

1. Grants to the Agent, as security for the Obligations, a security interest in and to the trademarks listed in Exhibit A and to the Goodwill, and a security interest in and to all trademarks and Goodwill acquired by Grantor after the date hereof;

2. Grants to the Agent, as security for the Obligations, a security interest in and to any license agreements in which Grantor is or becomes licensed to use know-how, a patent,

copyright, trademark, trade secret or other proprietary right (except to the extent that such license agreements grant licenses which by their terms may not be assigned or otherwise transferred or encumbered by the Grantor; and

3. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to note in the record the existence of the security interest granted hereunder with respect to each of the trademarks listed in Exhibit A and, subject to any restrictions on assignment and the granting of liens thereon, to the Goodwill and to all trademarks and Goodwill acquired by Grantor after the date hereof.
