**GIFT TRADEMARK ASSIGNMENT**

RECITALS

WHEREAS Michael C. Houlihan ("Mr. Houlihan"), a United States citizen and the President and Chief Executive Officer of Grape Links, Inc., a California corporation doing business as Barefoot Cellars Winery, located at 420 Aviation Boulevard, Suite 106, Santa Rosa, California 95403 (the "Company"), is the proprietor of the registered marks as per Schedule A attached hereto (the "Marks"); and

WHEREAS Bonnie M. Harvey ("Ms. Harvey"), a United States citizen and the Vice President of the Company, is desirous of acquiring one-half (1/2) of Mr. Houlihan's interest in the Marks together with the business and the goodwill of the business in connection with which the Marks are used insofar as they relate to and cover the territory of the United States; and

WHEREAS Mr. Houlihan desires to gift, assign, irrevocably transfer, convey and deliver to Ms. Harvey one-half (1/2) of the rights, title and interest in and to the Marks, free and clear of any and all applicable federal and state gift taxes or other liens:

ASSIGNMENT

NOW, THEREFORE, Mr. Houlihan hereby gives, assigns, irrevocably transfers, conveys and delivers to Ms. Harvey one-half (1/2) of the rights, title and interest in and to the Marks together with the goodwill symbolized by the Marks and that portion of the business which is ongoing and existing to which the Marks pertain. Such transfer is intended by Mr. Houlihan as a gift without consideration effective upon the Effective Date of this Gift Trademark Assignment.

GIFT TAXES AND LIENS

Mr. Houlihan agrees to pay any and all applicable federal and state gift taxes that may be required as a result of the transactions contemplated by this Gift Trademark Assignment.

FURTHER ASSURANCES

Mr. Houlihan agrees to execute, acknowledge and deliver or cause to be executed, acknowledged and delivered to Ms. Harvey such other instruments of transfer, assignment and conveyance as shall be necessary or desirable to vest in Ms. Harvey all the right, title and interest in and to the Marks and to implement the purposes of this Gift Trademark Assignment.

LEGAL COUNSEL

Mr. Houlihan and Ms. Harvey understand and acknowledge that the law firm of Pillsbury Winthrop LLP has acted as counsel to the Company, and has not represented Mr. Houlihan's or Ms. Harvey's interests as individuals. Accordingly, the Company strongly encourages Mr. Houlihan and Ms. Harvey, and Mr. Houlihan and Ms. Harvey hereby acknowledge having been encouraged, to seek independent counsel in connection with the decision to become a party to this Gift Trademark Assignment.


