#### TRADEMARK SECURITY AGREEMENT SUPPLEMENT

THIS TRADEMARK SECURITY AGREEMENT SUPPLEMENT is entered into and effective this 30th day of September, 2004 (this "Trademark Security Agreement"), by MITSUBISHI MOTORS NORTH AMERICA, INC., a California corporation (the "Grantor") and THE BANK OF TOKYO-MITSUBISHI, LTD., NEW YORK BRANCH, a Japanese banking corporation, in its capacity as the collateral agent (the "Collateral Agent") for the MMCA Secured Parties (as referred to in the MMNA Subordinated Security Agreement (MMCA Obligations), as hereinafter defined). The Grantor and the Collateral Agent are sometimes collectively referred to herein as the "Parties".

#### **RECITALS**

- A. The capitalized terms used in this Trademark Security Agreement shall have the same meaning as given to them in the MMNA Subordinated Security Agreement (MMCA Obligations) (as hereinafter defined), unless otherwise specifically provided herein.
- B. Pursuant to that certain MMNA Subordinated Security and Pledge Agreement (MMCA Obligations), dated September 30, 2004, between the Grantor and the Collateral Agent (the "MMNA Subordinated Security Agreement (MMCA Obligations)"), the Grantor has granted to the Collateral Agent a continuing security interest in, and Lien on, the Collateral, including without limitation the Trademarks, the Trademarks Licenses and related trademark rights under the concept of Intellectual Property (collectively, the "Trademark Collateral"). The Trademark Collateral includes, but is not limited to, the copyright applications and registrations set forth in Schedule "A" attached hereto.
- C. Pursuant to the MMNA Subordinated Security Agreement (MMCA Obligations), the Parties hereto wish to confirm the Grantor's grant to the Collateral Agent of a continuing security interest in, and Lien on, the Trademark Collateral, including, but not limited to the trademark applications and registrations set forth in Schedule "A" attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. The Grantor hereby grants to the Collateral Agent, and the Collateral Agent hereby accepts from the Grantor, a continuing security interest in, and Lien on, the Trademark Collateral, including, but not limited to the trademark applications and registrations set forth in Schedule "A" attached hereto, and all goodwill of any business associated therewith or symbolized thereby.
- 2. This security interest is granted in conjunction with the security interest granted to the Collateral Agent, as set forth more fully in the MMNA Subordinated Security Agreement (MMCA Obligations).
- 3. The rights and remedies of the Collateral Agent with respect to the security interest in, and Lien on, the Trademark Collateral and granted hereby are without prejudice to and without limitation of those rights and remedies of the Collateral Agent which are set forth in MMNA Subordinated Security Agreement (MMCA Obligations), the terms and provisions of which are in no way limited, qualified, amended or negated by this Trademark Security Agreement.
- 4. In the event of any conflict between the terms and provisions of this Trademark Security Agreement and those of the MMNA Subordinated Security Agreement (MMCA Obligations), the terms

and provisions of the MMNA Subordinated Security Agreement (MMCA Obligations) shall govern and control.

- 5. Subject to paragraphs 2, 3 and 4 hereof, this Trademark Security Agreement sets forth the entire agreement and understanding between the Parties hereto with respect to the subject matter hereof, and supercedes all prior agreements, drafts of agreement, understandings and commitments, whether oral or written, related to such subject matter.
- 6. This Trademark Security Agreement may only be modified or amended by a further agreement in writing executed by both Parties hereto, in accordance with Section 21.12 of the MMNA Subordinated Security Agreement (MMCA Obligations).
- 7. THIS TRADEMARK SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, EXCEPT AS REQUIRED BY MANDATORY PROVISIONS OF LAW OR TO THE EXTENT THE PERFECTION OR PRIORITY OF THE SECURITY INTERESTS HEREUNDER, OR THE RIGHTS AND REMEDIES HEREUNDER, IN RESPECT OF ANY TRADEMARK COLLATERAL ARE GOVERNED BY THE LAW OF A JURISDICTION OTHER THAN NEW YORK.
