PATENT AND TRADEMARK SECURITY AGREEMENT

PATENT AND TRADEMARK SECURITY AGREEMENT, dated as of May 9, 2003 (this "Patent and Trademark Security Agreement"), by each of the parties listed on the signature pages hereof and those additional entities that hereafter become parties hereto by executing the form of Supplement attached hereto as Annex 1, as grantors (collectively, the "Grantors", and individually, each a "Grantor"), in favor of WACHOVIA BANK, NATIONAL ASSOCIATION, in its capacity as Collateral Agent for the Lenders (the "Agent").

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement dated as of the date hereof among the financial institutions from time to time parties thereto (such financial institutions, together with their respective successors and assigns, are referred to each individually as a "Lender" and collectively as the "Lenders"), Wachovia Bank, National Association, as administrative agent, collateral agent and co-agent, Bank of America, N.A., as syndication agent, documentation agent and co-agent, Banc of America Securities LLC, as co-arranger and co-book runner, Wachovia Securities, Inc., as co-arranger and co-book runner, Salton, Inc., a Delaware corporation (the "Parent"), each of the Parent's Subsidiaries identified on the signature pages thereof as borrowers (the Parent and such Subsidiaries are referred to hereinafter each individually as a "Borrower", and individually and collectively, jointly and severally, as the "Borrowers") and each of the Parent's other Subsidiaries identified on the signature pages thereof as guarantors (including all annexes, exhibits and schedules thereto and as from time to time amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders have agreed to make the Loans to the Borrowers and to issue Letters of Credit on behalf of the Borrowers and guaranteed by the Guarantors;

WHEREAS, each Grantor is a party to the Credit Agreement, as either a Borrower or as a Guarantor;

WHEREAS, the Agent and the Lenders are willing to make the Revolving Loans and to provide the other financial accommodations as provided for in the Credit Agreement, but only upon the condition, among others, that each of the Grantors shall have executed and delivered to the Agent, for itself and the ratable benefit of the Lenders, this Patent and Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. <u>DEFINED TERMS</u>. The following terms shall have the following respective meanings:

"Patent" means all of the following in which any Grantor now holds or hereafter acquires any right, title or interest: (a) all patents of the United States or any other country, all registrations and recordings thereof, and all applications for patents of the United States or any other country, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State or Territory

thereof, or any other country; (b) all reissues, continuations, continuations-in-part or extensions thereof; and (c) all licenses, fees, royalties, damages or payments with respect to the foregoing.

"<u>Patent Licenses</u>" means any and all rights under any written agreement now owned or hereafter acquired by any Grantor granting any right with respect to any invention on which a Patent is in existence.

"Trademark" means all of the following in which any Grantor now holds or hereafter acquires any right, title or interest: (a) all trademarks, trade names, corporate names, business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature (whether registered or unregistered), all registrations and recordings thereof, and all applications in connection therewith, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state or territory thereof, or any other country or any political subdivision thereof; (b) all reissues, extensions or renewals thereof; and (c) all licenses, fees, royalties, damages or payments with respect to the foregoing.

"<u>Trademark Licenses</u>" means any and all rights under any written agreement now owned or hereafter acquired by any Grantor granting any right to use any Trademark.

All other capitalized terms used but not otherwise defined herein have the meanings given to them in <u>Annex A</u> thereto to the Credit Agreement.

Each Grantor hereby grants to the Agent, on behalf of itself and the Lenders, a continuing first priority security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Patent and Trademark Collateral"):
 - (a) all of its Patents and Patent Licenses to which it is a party, including those referred to on Schedule I hereto;
 - (b) all of its Trademarks and Trademark Licenses to which it is a party, including those referred to on <u>Schedule II</u> hereto;
 - (c) all reissues, continuations or extensions of the foregoing;
 - (d) all goodwill of the business connected with the use of, and symbolized by, each Patent, Patent License, Trademark and Trademark License; and
