TRADEMARK ASSIGNMENT AGREEMENT

- (a) The trademarks, service marks and trade names identified by Exhibit A hereto (collectively, the "Marks") and the goodwill of the respective businesses symbolized by the Marks;
- (b) All registrations, registration applications, renewals, reissues, continuations, extensions or the like of any Mark and like protection, including without limitation, those obtained or permissible under past, present and future laws and statutes of the United States, any state or any other country or place anywhere in the world;
- (c) All rights of action on account of past, present, and future unauthorized use of any of said Marks, and for infringement of said Marks and like protection; and
- (d) The right to file and prosecute applications for registration of said Marks in the United States or any other country or place anywhere in the world.
