

## ASSIGNMENT OF TRADEMARK

This is an assignment made August ~~24~~, 2004 from Genmar IP LLC, a Delaware corporation having a place of business at 2900 IDS Center, 80 South Eighth Street, Minneapolis, Minnesota 55402 (hereinafter "Assignor") to Brunswick Corporation, a Delaware corporation having an address of 1 Northfield Court, Lake Forest, Illinois 60045 (hereinafter "Assignee").

WHEREAS Assignor has entered into a stock purchase agreement with Assignee providing, among other things, to transfer to Assignee Assignor's right, title and interest in and to intellectual property, including the trademark BARON, and corresponding trademark application for "BARON", Serial No. 78/281,379 filed July 31, 2003.

NOW, THEREFORE, for good and valuable consideration paid to Assignor by Assignee, receipt of which is hereby acknowledged, Assignor hereby assigns, sells, transfers and sets over onto Assignee its entire right, title and interest in and to the "BARON" trademark, including, without limitation, trademark application Serial No. 78/281,379 for the mark "BARON" along with the good will associated therewith, and further including the right to sue and recover for any past infringement damages, said assignment to be effective as of April 1, 2004.

ASSIGNORS agree that upon request they will, at any time without charge to Assignee but at Assignee's expense, furnish all necessary documentation relating to or supporting chain of title, sign all papers, take all rightful oaths, and do all acts which may be reasonably necessary for the vesting of title in the "BARON" trademark being transferred hereby in Assignee, its successors, assigns and legal representatives or nominees, including but not limited to any acts which may be reasonably necessary for claiming said rights and for securing and maintaining the BARON trademark being transferred hereby and for vesting title thereto in Assignee and its respective successors, assigns and legal representatives or nominees.
