#### **GRANT OF TRADEMARK SECURITY INTEREST**

WHEREAS, the undersigned signatories (the "Grantors") own and use in their businesses, and will in the future adopt and so use, various intangible assets, including the Trademark Collateral (as defined below); and

WHEREAS, DAN RIVER INC., a Georgia corporation, as debtor and debtor in ("Borrower") has entered into a Post-Petition Credit Agreement dated as of April 1, 2004 (said Credit Agreement, as it may heretofore have been and as it may hereafter be amended, supplemented or otherwise modified from time to time, being the "Credit Agreement") with the financial institutions and other entities named therein (collectively, together with their respective successors and assigns party to the Credit Agreement from time to time, the "Lenders") and Deutsche Bank Trust Company Americas, as Administrative Agent for the Lenders (in such capacity, the "Secured Party"), pursuant to which the Lenders have made certain commitments, subject to the terms and conditions set forth in the Credit Agreement, to extend certain credit facilities to the Borrower; and
