ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT is made as of December 29, 2003 by Health Sense International, Inc., (referred to herein as "HSI"). in favor of Accelerated Care Plus Corp. (referred to herein as "ACP").

RECITALS

WHEREAS, pursuant to that certain Purchase Agreement (as defined below), HSI and ACP wish to assign to ACP, the entire right, title and interest in, to and under the trademarks, copyrights, applications and other intellectual property listed in Exhibit A to the Purchase Agreement to the extent specified on Exhibit A to the Purchase Agreement, together with all foreign rights corresponding thereto, any reissues, extensions, substitutions, confirmations, divisions and continuations of any of the foregoing and all the rights to sue and recover for past infringement thereof (the "Assigned Intellectual Property Rights"); and

WHEREAS, ACP and HSI wish to ensure that ACP has acquired all right, title and interest in and to the Assigned Intellectual Property Rights to the extent specified on Exhibit A;

NOW, THEREFORE, for good and valuable consideration as contained in the Asset Purchase Agreement dated December 9, 2003 among HSI and ACP (the "Purchase Agreement"), the receipt and sufficiency of which is hereby acknowledged, HSI does hereby sell, assign, transfer and convey to ACP, its entire right, title and interest in and to the Assigned Intellectual Property Rights to the extent specified on Exhibit A, to have and to hold for the sole and exclusive use and benefit of ACP forever.

HSI hereby covenants and agrees, for itself and for its legal representatives, to assist and cooperate with ACP in the preparation and prosecution of any applications included within the Assigned Intellectual Property Rights in the prosecution or defense of any interference, opposition or other proceeding that may arise in connection with the applications or other intellectual property included within the Assigned Intellectual Property Rights, subject to appropriate reimbursement for expenses and time incurred in such assistance, and further to execute and deliver to ACP any and all additional papers that may be requested by ACP for the purpose of implementing the terms of this Agreement.
