TRADEMARK RELEASE

This RELEASE is given as of this 30th day of September 2004 by The Bank of Nova Scotia, a Canadian chartered bank ("Assignor"), located at One Financial Place, 1 Adelaide Street East, 9th Floor, Toronto, Ontario M5C 2W8, in favor of The Singer Company Limited, a corporation incorporated under the laws of the Isle of Man ("Assignee"). Capitalized terms not otherwise defined herein have the meanings set forth in the Trademark Security Agreement (Canada), dated as of October 30, 1998 between Assignee and Assignor (the "Security Agreement").

WHEREAS, pursuant to the Security Agreement, as general and continuing collateral security for the due payment and performance of all IP Obligations and Obligations, Assignee granted to Assignor, to the full extent of its interest therein, a first security interest in and to (i) each of the Trademarks (including, without limitation, each trademark and service mark registration and application identified in Schedule A attached hereto and incorporated herein by reference), including all goodwill of the business of Assignee symbolized by each of the Trademarks and all rights of Assignee as the registered owner of the Trademarks, including all rights to receive royalty, license or other payments due to Assignee from any registered user or other use of any of the Trademarks, (ii) the customer lists and other records of Assignee relating to the distribution of products bearing any of the Trademarks, (iii) any present or future claim by, or right of action of, Assignee against any person with respect to the infringement of any of the Trademarks, and (iv) all present or future Proceeds of any of the foregoing (together the "Security Interests"), which Security Interests were recorded in the United States Patent and Trademark Office on July 18, 1999 at Reel 1925 / Frame 0600; and

WHEREAS, the IP Obligations and Obligations have indefeasibly been paid and performed in full and Assignor desires to release its Security Interests.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its Security Interests and reassigns without representation, warranty or recourse any and all interest that it may have in the Security Interests to Assignee.

At any time and from time to time, Assignor hereby agrees, without further consideration other than reimbursement of all costs and expenses incurred in connection with such action, to deliver to Assignee such other releases, termination statements, or other documents or instruments prepared by Assignee, and agrees to take such other actions, as Assignee may reasonably request to more fully evidence the release of all security interests and liens of Assignor effected hereby.
