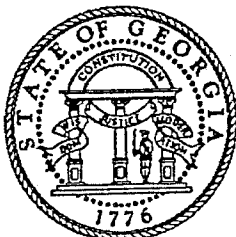

ARTICLES OF AMENDMENT  
OF

Pursuant to Section 14-2-1002 of the Georgia Business Corporation Code, the Board of Directors of GOULD PLASTICS, INC. (the "Corporation"), a corporation duly organized and legally existing under the laws of the State of Georgia, did, by a Consent in Lieu of Special Meeting of the Board of Directors, amend the Articles of Incorporation of said Corporation as follows:
