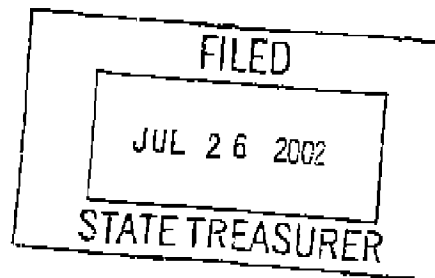

**CERTIFICATE OF AMENDMENT  
TO CERTIFICATE OF INCORPORATION  
OF

The undersigned has executed and is filing this Certificate of Amendment, pursuant to unanimous vote of the Shareholders of Lucerne Manufacturing Co., Inc. and in accordance with the provisions of the New Jersey Business Corporation Act.

**FIRST:** The Certificate of Incorporation presently provides that the name of the Corporation is **LUCERNE MANUFACTURING CO., INC.**

**SECOND:** The Certificate of Incorporation is hereby amended to provide that the name of the Corporation is **ACCURATE BUSHING COMPANY, INC.**

**THIRD:** This amendment was adopted as of the 22 day of July, 2002 by unanimous vote of shareholders. There were 825 shares with voting rights; 825 shares voted in favor of the amendment.
