**Amended and Restated Grant of Security Interest
in United States Patents and Trademarks**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Duane Reade, a New York general partnership, Duane Reade Inc., a Delaware corporation, DRI I Inc., a Delaware corporation, and Duane Reade International, Inc., a Delaware corporation (each a "Grantor"), each with offices at 440 Ninth Avenue, New York, New York, 10001, each hereby confirm the continuing grant, and to the extent not already created, each grant to US Bank National Association (as successor to Bank of America N.A.), as Collateral Agent, and all successors and permitted assigns of the Collateral Agent (the "Grantee"), with offices at 225 Asylum Street, 23rd Floor, Hartford, CT 06103, a security interest in all of the Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Patent and Trademark Collateral"), whether presently existing or hereafter arising or acquired:

- (a) each United States patent and patent application, including each Patent and Patent Application referred to on Schedule A hereto;
- (b) each Patent License, including each Patent License listed on Schedule A hereto;
- (c) each United States trademark, trademark registration and trademark application, and all of the goodwill of the business connected with the use of, and symbolized by, each trademark, trademark registration and trademark application, including each Trademark, Trademark Registration and Trademark Application referred to in Schedule B hereto;
- (d) each Trademark License, whether registered or not, including each Trademark License referred to in Schedule B hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- (e) all products and proceeds of the foregoing, including any claim by the Assignor against third parties for past, present or future infringement of any Patent, or past, present or future infringement or dilution of any Trademark or Trademark registration, including any Patent or Trademark listed on Schedule A or B hereto, or under any Patent or Trademark licensed under any Patent License or Trademark License, including any such License listed on Schedule A or B hereto, or for injury to the goodwill associated with any Trademark, Trademark registration or Trademark License.


THIS SECURITY INTEREST has been granted in conjunction with and in continuation of the security interests granted to the Grantee pursuant to the Security Agreement, dated July 30, 2004, as amended by the Amended and Restated Security Agreement among the Grantor, the Grantee and certain other parties dated as of December, 20 2004 (the "Effective Date"), as such documents may be amended, modified or supplemented from time to time (the "Amended and Restated Security Agreement").

The rights and remedies of the Grantee with respect to the security interest described herein are without prejudice to, and are in addition to those set forth in the Amended and Restated Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Amended and Restated Grant of Security Interest are deemed to conflict with the Amended and Restated Security Agreement, the provisions of the Amended and Restated Security Agreement shall govern.


